Subject:- Selection of Candidate for Private Coaching/Tuition Centres under 10% Reserved Departmental Quota for the session 2021-22 under Orphan/AAY/Physical challenged/PHH (BPL)/Destitute/under privileged (other) Category.

ORDER

Whereas, Govt. Order No: 445-Edu of 2010 dated: 30-04-2010 Stipulates that 10% Reserved Departmental Quota of the total in-take capacity be reserved for the students belonging to Orphan/AAY/Physically challenged/PHH(BPL)/Destitute/under privileged category in Private Coaching/Tuition Centres; and

Whereas, this office vide notification bearing No: DSEK/GS/1705 dated: 13-11-2021 had invited online application on the official website www.dsek.nic.in from the aspirant students for free coaching under 10% .Reserved Departmental Quota for the session 2021-22 under Orphan/AAY/Physically challenged/PHH/ BPL/Destitute/under privileged category; and

Whereas, a departmental committee comprising of Joint Director (SSA), Personnel Officer, and SLO, DSEK was constituted to scrutinize the cases as per norms and make recommendations accordingly

Accordingly, on the basis of recommendations of designated committee followed by computer based randomisation, Sanction is hereby accorded to the selection of **11787** candidates reflected in the Annexure to this order in Private Coaching/Tuition Centres under 10% Reserved Quota for the session 2020-21 under Orphan/AAY/Physically Challenged/PHH (BPL)/Destitute/under privileged (other) categories subject to the following conditions:-

1. *The concerned Private Coaching/Tuition Centres are advised to check the authenticity of the reserved category with the original documents before the selected candidate is allowed to join for free coaching under 10% departmental reserved quota.*
2. *The concerned Private Coaching/Tuition Centres shall not allow the selected candidate, in case of any variation in the particulars of the selected candidates reflected in the order especially the category under selected and same shall be conveyed to this office within one week.*
3. *That the Selected candidates having any grievance shall approach this office within weeks time .*
4. *That the concerned Private Coaching/Tuition Centres shall submit the compliance report about joining of the student in the particular coaching centre to this office within 15 days.*
5. *The Heads of coaching centres shall ensure implementation of SOP's in view of COVID-19 pandemic as notified by the Ministry of Home Affairs, Govt. of India and Ministry of Health & Family Welfare, Govt. of India and the Govt. of U.T Jammu & Kashmir.*


